MISSION STATEMENT

Beryl Women's Refuge recognises that violence against women and children is prevalent in our society and believes it be be intolerable. Injustices such as sexism, racism, economic inequality and homophobia, etc. contribute to families living in crisis. To redress this Beryl Women's Refuge is committed to providing a professional and accountable service that is based in justice and equality; recognising and fostering cultural diversity within the service and the broader community. We work towards this through empowering women and children with care, respect and acceptance.

SERVICE REPORT 1997-98

Staff

The restructuring process which has seen the service move away from a collective structure where all workers had the same duties is now complete. Whilst still utilising collective principles, we have incorporated into the management structure a co-ordinator and an administrative worker. Unfortunately, in 1997-98 we had some difficulties finding an appropriate person to fill the position of coordinator. Our current administrative worker, Sharon Williams, was employed in July 1997, and she brings extensive professionalism and expertise to the service.

This financial year unfortunatley saw the departure of our muchvalued relief workers, Shona Chapman, Penny Coventry, Olga Correa, and Krishna Sudhana, and one of our relief workers obtained permanent work with us, Maria-Eleni Alessandre. We were also very sad to Grace Coe take a year's leave without pay. We welcome Dorothy Charles who is filling Grace's position. We also thank Kestrel McEune for her valuable work as contract Children's Support Worker, and we welcome Margie Coe back from maternity leave.

We also thank those people who contribute to the general upkeep of our premises: Lanceine Walford our popular cleaner, Jill Christie our hardworking gardener, and Linda Hayden our resourceful maintenance worker.

We also saw some changes to our Extended Collective, the management committee of Beryl Women's Refuge. We thank Sarah Khalidi for her valuable input, and we welcome two new additions, Sabine Zanker, and Alison Rodway. Sabine has been instrumental in the selection processes involved in employing a coordinator, and Alison contributed many hours of her expertise in the preparation of our Evaluation of the 1996-97 Management Plan, and the 1997-98 Management Plan. We also thank Mirtha Abello for her continuing input both as an Extended Collective Member, and as our book-keeper. Mirtha has successfully faciliated the service's transition to computerised accounting.

Client Services

Beryl Women's Refuge continues to offer a wide range of services to women and children from domestic violence situations, such as accommodation, supported crisis counselling. referral and advocacy, court support, therapeutic workshops, follow-up, and outreach. This financial year has seen the service further formalise its case management approach to client service delivery. By the end of June 1998, 85% of all families coming to the service had a case plan. The remaining 15% who did not have a case plan were those who only stayed in the service for a very short period of time (ie. under one week). We are continuing to fine-tune our case management approach to children.

We have continued to run workshops for both our women and children clients as well as ex-clients, including a puppet workshop, an 8 week therapeutic workshop for children covering such issues as self-esteem, feelings, and conflict resolution, and a 6 week art therapy workshop for women which was also attended by a member of the general community. Feedback on these workshops has been positive, and we continue to implement innovative approaches to working with women and children from domestic violence backgrounds. We have also engaged in various projects in upgrading the service's premises. We have an large new shadecloth covering the children's sandpit, and a substantial area of the backyard which provides much needed protection in the summer months. The 2 houses also have bright new curtains which have certainly contributed to a more welcoming atmosphere. Further such projects have been planned for the following financial year, such as painting, and re-carpeting.

Highlights of 1997-98

One of the highlights of the year was the Community Arts Project art exhibition, "Crying Out Loud" which was organised by one of Beryl's support workers, Judy Hammond. With help from the rest of the team, Judy put in a major effort to bring this exhibition together. The exhibition displayed women's and children's art work which had been done during the course of the service's client workshops, and also involved extensive client participation in its organisation.

EXAMPLE OF INDIVIDUAL FAMILY SUPPORT & OUTCOMES

The following are characteristic examples of support provided to an individual family, and of client family outcomes. To protect client confidentiality, these are composite profiles representing some typical kinds of support provided and outcomes achieved.

Support Provided

- Assistance to obtain Domestic Violence Order
- Exploration of housing options
- Assistance and advocacy provided to obtain Social Security benefits
- Assistance and advocacy provided to apply for government housing, eg. writing and obtaining support letters and other necessary documentation, accompanied to housing interview
- Referral to Child At Risk Assessment Unit for trauma-related symptoms of children
- Assistance provided to write job applications
- Facilitated client workshops which both mother and children attended
- Crisis counselling
- Referral to legal aid
- Assistance provided for criminal compensation claim
- Assistance in enrolling and taking children to school
- Referral to Women's Health Service


Individual Family Outcomes


- Domestic Violence Order obtained

SERVICE DEMOGRAPHICS


These service demographics are drawn from the agency's own data and not from the Agency Reports of the National Data Collection Agency. During the year we had 63 families come to our service, with a total of 183 clients. 


